## Chalice & Shire of Toodyay sign HOA for Community Fund

**Agreement reflects shared objective to deliver long-term benefits that flow to the local community from a potential mine development at Gonneville**

### Highlights

- « Chalice Mining and the Shire of Toodyay have signed a Heads of Agreement (HOA) for the future establishment of the Chalice Mining Community Fund.
- « The HOA establishes a framework under which Chalice and the Shire of Toodyay can plan and prioritise future spending initiatives to deliver long-term benefits and investment in the local community.
- « Since the Gonneville Nickel-Copper-PGE Project (Gonneville or Gonneville Project) discovery in 2020, Chalice has already contributed ~\$230,000 through its Community Investment Program and spent a further ~\$3 million on goods and services with local Toodyay businesses. An additional ~\$5 million has been spent by direct Chalice contractors.

### Overview

Perth-based exploration and development company Chalice Mining Limited ("Chalice" or "the Company") together with the Shire of Toodyay ("Shire") are pleased to announce the signing of a landmark Heads of Agreement (HOA) for the future establishment of the *Chalice Mining Community Fund*.

The agreement reflects a shared objective to deliver long-term benefits to the local community from a potential mine. The Gonneville Project is located on Chalice-owned farmland within the Shire of Toodyay.

Under the terms of the HOA, Chalice has agreed to provide funding for the delivery of community projects and programs that have been identified by the Shire of Toodyay and that align with Chalice's eligibility criteria.

Eligible projects will demonstrate community development and social investment priorities that are aligned with and preserve and promote the Shire of Toodyay's Council Plan, with a focus on local employment and training outcomes as well as other initiatives that contribute to community sustainability.

This framework will also form the basis for Chalice to establish similar community funds with other neighbouring Shires in the region.

Chalice Managing Director Alex Dorsch said the HOA helped formalise the Company's strong commitment to community development and provided guidelines for Chalice to work with the Shire of Toodyay to ensure community spending delivered long-term benefits for local residents.

The completion of a formal agreement and the establishment of the Community Fund are contingent on the Chalice Board making a Final Investment Decision (FID) in favour of proceeding with a development at the Gonneville Project, and the project achieving all the necessary approvals and funding requirements.
