### 2.1 RDA WHEATBELT

Mandy Walker, Regional Director of RDA Wheatbelt presented her Zone Report that will be presented to the Avon Midland Country Zone meeting in a week's time.

Discussion Points were as follows:

- RDA can be the Connector and collaborator; an independent body coordinating projects on local government's behalf;
- Local Service delivery;
- Attraction of young people to the bush;
- Correspondence in relation to jobs for case studies of people who have moved from the city to our town and why they moved and what successes did they have;
- Education Service delivery an issue in regional areas up to. Middle school was start of the process in Goomalling but still scope to do more;
- RDA could play a role (Refer to page 4 of attached Report) as an aim of a project is to have a look at a regional university centre. If we can train people in the regions they will stay in the regions and work. If we had another university, not just Agriculture, but also engineering, nursing, allied Health, etc.
- Jobs having workforce attraction. Expand existing industries;
- Minister asked regional bodies to change the narrative around working in the country especially in the medical or allied health fields. Some people see the country as a B Grade experience and the city as an A Grade experience;
- Biosecurity Programmes in Perth;
- Perception of country – the social life cannot get in the country;
- Kids more inclined to need entertaining as opposed to going out to find entertainment;
- Social engagement. In 1910 60% people lived in country towns and in 2010 60% - 80% live in the city;

**PURPOSE**

To consider action to advocate for an amendment to the *Mining Act 1978* to mandate that benefits are provided to communities located in close proximity to significant resource projects.

**BACKGROUND**

The State Government of Queensland has adopted the *Strong and Sustainable Resource Communities Act 2017* (SSRC Act) which ensures that residents of communities near large resource projects benefit from the construction and operation of those projects.

Under the QLD SSRC Act, large resource projects are those resource projects for which an environmental impact statement is required, or that hold a site-specific environmental authority and have 100 or more workers.

A nearby regional community is one that is within 125-kilometre radius of a large resource project and has a population of more than 200 residents.

On 30 March 2018, the Act's three key elements commenced:

1. 100% fly-in, fly-out (FIFO) prohibition;
2. anti-discrimination;
3. social impact assessment.

**COMMENT**

The Shire of Toodyay has recently been informed of a significant mineral discovery by Chalice Gold Mines Limited within its boundaries (the Julimar

Project). The Julimar Project also encompasses areas of the Julimar State Forest, the Shires of Chittering, Mundaring, Northam, Victoria Plains and York, and the City of Swan.

Given the impacts of mining on regional communities, it is proposed that the AROC considers advocacy activity to encourage mandated benefits for communities affected by significant resource projects.

This matter was raised at the AROC Officer's meeting held recently. Officers agreed that legislative change is unlikely without a comprehensive and concerted campaign supported by local governments and other regional organisations across the state.

It is proposed that AROC requests that an item be placed on the agenda for the next possible meeting of the Avon-Midland Country Zone to discuss the possibility of sector-wide advocacy regarding this matter.

## OFFICER'S RECOMMENDATION

That AROC requests the Avon-Midland Country Zone to discuss collaborative advocacy activity regarding the mandated provision of benefits to communities affected by significant resource projects.

Cr Madacsi provided an overview of the above report.

### REGIONAL DEVELOPMENT AUSTRALIA ARRANGEMENTS UPDATE

Regional Development Australia (RDA) is a national network of Committees made up of local leaders who work with all levels of government, business and community groups to support the economic development of their regions. RDA Committees have an active and facilitative role in their communities with a clear focus on growing strong and confident regional economies that harness their competitive advantages, seize economic opportunities and attract investment.

The RDA Network plays a key role supporting the Commonwealth Government's regional development policy objectives. The Government is recommitting to the program, with a number of proposed improvements, including:

- A long-term funding agreement to 30 June 2025
- Restoring indexation to RDA funding
- Streamlining the Charter to focus on key government priorities
- The ambition to seek greater alignment with State and Territory and local governments in each jurisdiction.

The charter has been reduced from ten points to four to achieve the overall goal of strong, confident and vibrant regions. Collaborating with other RDA Committees, all levels of government, and the private sector, RDA Committees will:

- a) Facilitate regional economic development outcomes, investment, local procurement and jobs.
- b) Promote greater regional awareness of and engagement with Australian Government policies, grant programs and research.
- c) Improve Commonwealth regional policy making by providing intelligence and evidence-based advice to the Australian Government on regional development issues.
- d) Co-ordinate the development of a strategic regional plan, or work with suitable existing regional plans that will align with the Commonwealth's regional priorities.

### WANDER THE WHEATBELT

RDAW continues to collaborate with Wheatbelt Arts and Events Inc (previously York Arts and Events) to build a Local Tourism Organisation model that will provide an organisation and online platform for the promotion of Wheatbelt arts, events, attractions and immersive activities. We are nearing the completion of a Business Plan and Strategic Plan that will guide the formation and delivery of services in this organisation.

Our vision is to be renowned as Australia's Wheatbelt we want to provide an opportunity for tourism, events, arts, culture and Wheatbelt Noongar arts and tourism businesses to promote their product to local, national and international travellers through an interactive online marketing platform. We also want to provide subscription and fee for service opportunities to key stakeholders.

Our mission is to be an established advocate and champion of arts, culture and tourism for Australia's Wheatbelt. We will be known as a reliable tourism vehicle for local governments, businesses and visitors by providing accurate promotion and holistic information accessible through an online platform.

Our goals are:

- To provide a service of value to subscribers in Australia's Wheatbelt;
- To become a Regional Tourism Organisation Australia's Wheatbelt, within 2 years;
- To promote Australia's Wheatbelt's culture including Noongar and First Nations arts and tourism opportunities; and
- To be an arts and tourism fee for service provider.

A subscription model is being developed with a Local Government stream and a business stream with three options. A summary of benefits for subscribers is being prepared. We will be offering a discount rate to the first 10 Local Governments to join and then enter an MOU for a further 3 years. These subscribers will be known as our hero subscribers. A similar model will be used for business subscribers with the first 20 to take out a "Super" subscription will be our hero businesses.

A PowerPoint presentation will be made to demonstrate the functions of the platform.

#### GRANT GURU

The WA RDA Grant Guru portal for Local Government and community groups across the Wheatbelt and Midwest Gascoyne regions was launched by Minister Price and Assistant Minister Marino in Geraldton on the 5<sup>th</sup> November.

RDAW has paid for the public portal that anyone can access. Local Governments who have paid a subscription have access to exclusive local government targeted grants. #### AGED AND DISABILITY CARE SERVICE DELIVERY

Our Regional Deal work has been reframed based on feedback from Minister Colbeck's office and the RDA Program. It became obvious that the plan to design a regional deal with the Federal Government was unlikely to be successful if we couldn't change the funding and policy setting that aged and disability care service delivery sits within. Advice was sought from Minister Colbeck, the Federal Minister for aged care. His office's advice was to focus on small pilot projects and access the funding streams made available through the Federal Government.

In light of this advice RDAW in collaboration with WA Primary Health Alliance are working with Directions Workforce to design a workforce solution that can be trialed across a number of Wheatbelt local governments. Directions is a community-based charity working with employers, apprentices, students and job seekers in WA. They can manage recruitment, mentoring, payroll and all dealings with TAFE if required. They do this for a fortnightly fixed cost, and we are exploring how we can match local workforce needs with personnel to fulfil those roles.

#### REGIONAL ACTIVATORS ALLIANCE

The Regional Activators Alliance (RAA) is a group of 37 regional stakeholders brought together by the Regional Australia Institute (RAI) to help create its national awareness campaign aimed at driving population to the regions.

Launched on Wednesday 28 October 2020 by Deputy Prime Minister the Hon. Michael McCormack, RAA members are at the forefront of this powerful national movement to change the narrative and show the rest of the country the opportunities available to live, work and invest in Regional Australia.

Activators will help co-create the campaign not only for the benefit of their region, but the nation as a whole. All aspects of the impact project will focus on RAI evidence-based research relating to four key pillars: Jobs, Population, Liveability and Leadership. RAA members will come together four times a year with relevant political, industry and community leaders invited to participate in the discussion and workshops.

RDAW has partnered with Regional Regeneration Alliance (RRA) to be the conduit for information in and out of the Wheatbelt region. Tess Slot from RAA will be the contact for Wheatbelt Local Governments to provide input into the national campaign. Tess will attend meetings on behalf of RDAW and represent the region by:

- supporting the development of the national campaign for brand Regional Australia
- providing data where useful and appropriate
- supporting stakeholder engagement and media communications functions to ensure a wider reach of the Regional Activators outputs
- providing bespoke support drawing on our regional expertise and strengths (both individually and collectively) to progress agendas arising from the Alliance

Thanks to Kerryn Chia, Project Officer at the Shire of West Arthur for prompting us to negotiate a regional membership for the RAA. RDAW made a case for one regional subscription instead of each Local Government joining the activators alliance which means that all Wheatbelt Local Governments can have input into, and benefit from, the findings of this research.

#### AVIATION AND AEROSPACE

Federal Government initiatives such as the Advanced Manufacturing Strategy and investment in defence industries has prompted us to consider the regional requirements and opportunities of aviation and aerospace industries in the Wheatbelt.

Building on the work the Wheatbelt Development Commission undertook several years ago, Chris Evans our Research and Project Officer has collated a current picture of aeroclubs, airports, aviation

industry participants, gliding and ultra-light clubs, helicopter services and flight schools in the region. In addition, he looked at location requirements for satellite launching, aerospace communications and observatories.

Our intention is to explore the opportunities in the region within the aviation and aerospace industry to participate in the initiatives that arise from the Advanced Manufacturing Strategy (due for release in March 2021) and also defence industries. We believe the Wheatbelt holds an underutilised level of strategic and natural asset capacity that could benefit the state and nation including regionally based repair and maintenance facilities, linking flight schools with a regional university and integrating aviation and aerospace into agri-tech.

#### REGIONAL UNIVERSITY CENTRE RESEARCH

In early 2021 we will be undertaking an environmental scan of Wheatbelt tertiary education opportunities and community interest to determine if we partner with a Local Government to pursue the development of a Regional University Centre.

Regional University Centres enable students in regional and remote Australia to access higher education without having to leave their community. Centres operate as a hub where students can access quiet study spaces, computers and academic support services.

The Regional University Centres program takes an innovative approach to improve access to tertiary education for regional and remote students. Importantly, they support students to remain in their local community and study online with any Australian university, providing student support and campus-like facilities in regional and remote areas across Australia.

A Regional University Centre is a facility regional students can use to study tertiary courses locally delivered by distance from any Australian institution. Centres provide:

- Infrastructure including study spaces, break out areas, video conferencing, computing facilities and high-speed internet access
- Administrative and academic support services such as developing writing and researching skills, managing administrative processes
- Student support services, including pastoral support, study advice and assisting with accessing student services

The Regional University Centres program aims to:

- enable students in rural, regional and remote Australia to access and complete higher education without having to leave their community
- meet a demonstrated gap in support for study in a regional, rural or remote community
- support students who wish to stay in their community while they complete their course of study
- enhance the experience of students studying within their own community
- encourage strong links with between the Centres and other organisations in the area, including other support services that students may access and industry; and
- complement, rather than replace, existing and planned university investments and activities in regional areas, such as satellite campuses and study centres.

On 19 October 2020, the Australian Parliament passed the legislation on the Job-ready Graduates Package (the package) which includes a further \$21 million to increase access and opportunities for

tertiary education in regional and remote areas by strengthening and expanding the Regional University Centres program.

Linked to the aviation, aerospace, agri-tech and general science, technology, engineering and maths (STEM) opportunities here in the Wheatbelt, we think this could be a great fit for our region. Coupled with courses in health and allied care, a Regional University Centre could play out to be an important part of our aged and disability care service sector workforce.

#### JOB VACANCY RESEARCH

On the 30th October RDAW was asked to participate in a national survey to gain insights into the current workforce issues being experienced in the region, particularly job vacancies. The RDA program is seeking to provide a whole of network response to government for use policy and program development.

Thank you to everyone who replied to a survey sent out by Pippa in our administration office. There has been a very cooperative response from across the region from businesses, local government, and CRCs. Your insights are much appreciated.

Key themes to come out of the survey in regards to the challenges we face in attracting staff for job vacancies are not surprising to most of us living in the region. They include availability of accommodation, visa restrictions, non-compliance with drug and/or alcohol tests, inability to drive a manual vehicle, distance of regional towns from Perth and rates of pay in some industries.

This feedback will be collated and shared not only with the RDA program for input into Federal Government processes but also our regional State and Federal members, the Wheatbelt Business Network and our regional chambers of commerce and industry.
