3.1.1 Regional Development Australia - Wheatbelt

Josh Pomykala, Director Regional Development. See attached report.

3.1.2 Wheatbelt Development Commission

No update.

3.1.3 Hon Rob Horstman MLC, Member for Western Australia, Shadow Minister for Emergency Services; Volunteering (online from 12.30pm).

Mr Horstman asked members to share their experience of emergency services matters.

A Behan - Matters raised included telecommunications connectivity and reliability; no resolution of long-standing issues despite engagement with Telstra (via Boyd Brown at the Avon Midland Zone meeting). Concerns that internet access via Starlink will not be covered by DFES grant scheme.

M Prinsloo - Chittering is advocating strongly for permission to use home package connections as two emergency management stations currently have no connectivity (not since 3G was decommissioned).

S Fletcher indicated NBN will use Starlink.

Members agreed that access to Starlink will solve connectivity issues for the volunteer bush fire brigades but not access issues for the general community.

D – Terelink gave an example of the CESM responding to an accident within one km from town where a lack of mobile phone coverage prevented responders from calling 000. Reported it is common to have no coverage within a 5km radius from town.

This also occurs on the Northam-Toodyay Rd, and along Toodyay Rd between Toodyay and Gidgegannup.

Cr Campbell reported consisted issues since 3G was turned off.

Cr Antonio asked when Blackspot funding will be available to access.

Mr Horstman will utilise the issues raised above as content to form a question without notice. He asked what leave arrangements are in place to accommodate CESM leave periods?

Members reported that there is often no replacement for the CESM during leave periods. DFES requests for CESM to be seconded to DFES roles also creates a challenge and cannot always be accommodated.

S Fletcher – Raised the issue of betterment funding not being available.

D Terelink - Asked when consultation regarding the Emergency Services Act will occur.

Cr Antonio – Raised issues with Great Eastern Highway and the Bindoon Bypass.

M Prinsloo – Chittering meets fortnightly with Main Roads to progress the bypass.

Mr Horstman – Thanked members for raising their concerns and identified questions on notice, questions without notice and tabling of petitions as ways in which he can raise issues in parliament. Mr Horstman also referenced the DFES annual report and the budget estimates hearing as avenues for him to ask questions of DFES.

***Action** – EO to distribute DFES Annual Report to members to identify issues that may be raised by Mr Horstman during budget estimates hearing.*

***Action** – EO to send calendar appointment to Mr Horstman to attend the next Governance Group meeting in March 2026.*

3.1.4 Tony Mahar, Australian Energy Infrastructure Commissioner (online)

Commissioner Tony Mahar and Deputy Commissioner, Carolyn Francis joined the meeting online and delivered a presentation (provided as an attachment to these minutes).

Following the presentation, members raised the following issues:

Cr Antonio – Commented that local governments are the service centre for renewable projects and not only the communities that are hosting them; non-disclosure agreements between renewable energy proponents and private landowners are causing grief for local governments, as is end of life decommissioning. An appropriate financial instrument is required to determine costs.

Cr Gibbs – Developers approaching private landowners without including the local government, which is faced with the real impacts on roads etc, is an issue; as is appropriate rating infrastructure.

At the Governance Group meeting on 1 September 2025, AROC Res. No. 03/09/2025 *'accepted the Shire of Chittering as a member of AROC; and referred the MOU to the Officer's Group to make agreed changes.'*

The EO outlined the changes to the MOU which was provided as an attachment to the agenda. Before moving to endorse the amended MOU and formally welcome the Shire of Chittering to AROC, members agreed to determine a change of name for AROC and incorporate this change into the MOU.

3.2.2 Warwick Carter, Director, Perth South West Metropolitan Alliance

Warwick spoke about the Perth South West Metropolitan Alliance and its approach to advocating on priorities. Warwick presented slides with key data for AROC members (see attachments) including unemployment over time, workforce, aged population and advice on advocating to state and federal government.

Key messages:

- AROC to identify themes/big issues that members agree on.
- Align your issues/initiatives with government priorities/outcomes and clearly demonstrate how AROC initiatives will assist the government to achieve their priorities. For example, with Federal Government AUKUS, social housing and homelessness are priorities.
- Use your government assets e.g. Sabine Winton, Minister for the Wheatbelt (WA); Trish Cook, Member for Bullwinkle (Federal) and the Hon Melissa Price, Member for Durack (Federal), to secure meetings and open up discussions with key advisors and Ministers.
- Key data shows unemployment is very low but aged population is higher than elsewhere which leads to vulnerabilities in health servicing and housing (for aged people but also for key workers in health and aged care).
- Suggestions for advocating in Canberra – use your local members to get access; get parliamentary visitor passes to improve access (need 6 weeks notice); meetings will be 15-20mins, keep number of representatives low, maximum of 3 people; make sure you have a 1 pager and follow-up with a detailed submission; use budget estimates submission process and don't visit during local government week; best days Tuesday and Wednesdays.
- Suggestions for state government - ~ \$2m was promised prior to the last election; get prepared early with submissions; work with government; use Minister Winton (Wheatbelt); Treasury and Treasurer are key. Priority focus is modular housing.

I write to inform you of my attendance at a workshop with the Avon Regional Organisation of Councils (AROC) in the Wheatbelt Region of Western Australia on 18 September 2025, and to request you consider scheduling a meeting with them as part of your work program.

At the forum, councils informed me of the significant scale of the roll-out of renewable energy infrastructure planned for the region, and the challenges this is presenting for rural councils with limited capacity to engage with energy proponents and constituents with complex concerns.

The AROC councils were particularly interested in the work of the Commission and during the forum we discussed your role in considering complaints from concerned residents about renewable energy and major transmission projects, and your broader work to identify and promote best practice relating to the planning, development and operation of renewable energy projects and new transmission.

I would be grateful if you would consider visiting the Wheatbelt to engage in a similar forum with local government at the appropriate time. Ms Kelly-Anne Murray, AROC Executive Officer, is a key contact who will be able to assist your office to arrange a meeting. She can be contacted at aroc@toodyay.wa.gov.au.

Dear AROC Councils

I am writing to thank you for giving me the opportunity to meet with the Avon Regional Organisation of Councils (AROC) on 18 September 2025. I would like to commend you on this forum. I found it very valuable, and it provided me with insights on a range of issues of importance to your region.

Renewable energy generation was of course an important element of discussion, and I acknowledge that the Wheatbelt is contributing to the heavy lifting to support new renewable energy generation and capacity in the South West Interconnected System. The significance of these developments underscores the need for energy infrastructure proponents to meaningfully engage and consult with the Local Government Areas (LGAs) in your region.

The Albanese Government is strongly encouraging energy infrastructure proponents to meaningfully engage and consult with local governments. In particular, the Government is implementing the Community Engagement Review in collaboration with the states and territories. This includes introducing a renewable energy developer ratings scheme (DRS) that was launched in August as a pilot. To receive a positive assessment under the DRS, energy proponents will need to demonstrate their credentials for good community engagement. I also wanted to acknowledge the feedback that some regional councils have limited capacity to engage with project proponents. I will raise this issue with the Western Australia Government.

We also discussed the role of the Australian Energy Infrastructure Commissioner in considering complaints from concerned residents about renewable energy and major transmission projects, and the work of the Commissioner's office in working across governments and with other stakeholders to support implementation of the recommendations from the Community Engagement Review and development of the DRS. I am in the process of writing to the Commissioner, Mr Tony Mahar, to ask that he come to the Wheatbelt to further engage with AROC and other wheatbelt councils.

As noted in our discussion, I encourage all councils to read the National Climate Risk Assessment and consider the information pertaining to their LGA. We will be considering local government feedback via the Western Australian Local Government Association (WALGA) in developing the action agenda for National Adaptation Plan and I encourage local governments to provide their feedback through WALGA.

Regarding betterment projects under the Disaster Recovery Funding Arrangements (DRFA), states are able to request the Prime Minister's agreement for exceptional assistance to cost-share betterment works to essential public assets following a significant disaster. These programs provide an opportunity to rebuild to a more resilient standard, with the goal to mitigate risks of future disaster events and their costs.

On 21 November 2023, the Prime Minister agreed to jointly fund \$104.9 million in betterment funding with the Western Australian government following Tropical Cyclone Ellie. This betterment program makes funding available to state agencies and affected local governments – in this case, Broome, Derby West Kimberley, Halls Creek and Wyndham East Kimberley – to undertake works for the reconstruction of assets impacted by the event, ensuring they are built to a stronger, more resilient standard. This is the first betterment fund implemented in Western Australia.

I encourage you to continue engaging with the Department of Fire and Emergency Services as the administering agency for DRFA in Western Australia on matters relating to infrastructure betterment.

Thank you once again for the opportunity to participate in the AROC forum on 18 September.

RDA Wheatbelt Update – AROC Meeting

Director Regional Development

RDA Wheatbelt continues to deliver a range of projects supporting sustainable growth and development across the Wheatbelt region.

In early October, Josh and Mischa Stratford (Committee Member) travelled to Canberra for the Regional Australia Institute's "Regions Rising National Summit". The summit included the official release of the "Regionalisation Ambition 2032 – Year 3 Progress Report", as well as opportunities for in-depth discussions with regional leaders from across the nation. Whilst in Canberra, Josh and Mischa were able to meet with a number of key people who have important roles across our programs. These include Senator the Hon Bridget McKenzie (Shadow Minister for Infrastructure, Transport and Regional Development, Leader of The Nationals in the Senate), the Hon Melissa Price MP (Shadow Minister for Defence Industry, Shadow Minister for Defence Personnel, Member for Durack), Rebecca Duncan (Senior Adviser to the Hon Kristy McBain MP, Minister for Emergency Management, Minister for Regional Development, Local Government and the Territories), and Brett Nordstrom (Assistant Secretary, Higher Education Program Delivery Branch).

Additionally, Josh attended the RDA National Forum held in Canberra from 4-6 November. 53 RDAs from across the country were represented over 2 days, with a number of challenges faced by regions across the country addressed through presentations and discussion panels.

Regular engagement with Local Government CEOs and Elected Members remains a key priority. These meetings provide opportunities to discuss local challenges, emerging opportunities, and ongoing or proposed projects. While our small team strives to attend as many regional events as possible, we remain available for support through in-person meetings, phone, email, or video conference.

Following the appointment of four new Committee Members in August 2025, RDA Wheatbelt is pleased to announce the appointment of Renata Paliskis as Chair. Appointed by the Australian Government Minister for Regional Development in October 2025, Renata brings extensive leadership experience, currently serving as CEO of Wheatbelt NRM and holding directorships across multiple organisations. I look forward to working with Renata on enhancing opportunities throughout the Wheatbelt. I also extend my thanks to our outgoing Committee Members, and welcome the organisation's new Committee Members, who all bring in-depth experience and knowledge from a broad range of areas.

Economic Development Training for Local Government

23 LGs have participated in RDA Wheatbelt's Economic Development Training for Local Government program, which has been very successful. This full-day workshop provides:

- Tailored data, reports, and resources specific to each participating Local Government;
- Guidance on analysing and applying this data through an economic development lens; and
- Strategic tools and case studies to explore new approaches and ideas.

The training is open to all staff and Elected Members involved in or interested in economic development. RDA Wheatbelt strongly encourages Elected Members to participate as key strategic decision-makers in their communities, particularly with a number of new Elected Members in the recent election.

The program will continue for participating Local Governments until November 2025. RDAW will seek interest from LGs to run the program again in 2026.

Training for Aboriginal Corporations and NFPs – Governance and Financial Management

RDA Wheatbelt is developing the next phase of a project to deliver culturally appropriate governance and financial management training for Aboriginal corporations and not-for-profit organisations. The business plan is currently being drafted to seek funding for the project, which will be brought in-house rather than seeking to contract a third party.

The program aims to:

- Align with Australian Government legislative requirements;
- Empower Boards and staff to strengthen governance capacity; and
- Include a 'train the trainer' component to build local leadership and sustainability.

An initial pilot will be delivered with selected organisations in the region, followed by a review to guide future regional rollout.

Research Evaluation – Aboriginal Student Achievement Through Secondary/Primary Schools Cluster Model Approach (Cluster Model)

RDA Wheatbelt has completed its undertaking of research work for the Ngala Koolangka Education Foundation Aboriginal Corporation, evaluating the effectiveness of the School Cluster Model (SCM) for improving Aboriginal student outcomes through language and cultural learning.

This work will underpin understandings of how the cluster model may be integrated into the Department of Education framework for the Wheatbelt, and serve as a basis for other initiatives that may be available to strengthen education delivery in the Wheatbelt.

Education in Regional Communities

RDA Wheatbelt continues its work in advocating strongly to the State and Australian Governments for greater support for regional and rural schools. Regional education is vital to the sustainability of regional communities and economic development, having large social and economic impacts throughout the region. Along with various stakeholders, RDA Wheatbelt is taking part in a coordinated approach to ensure the future of regional education is strong throughout the Wheatbelt. We continue to work with relevant policy makers and stakeholders to address the issues regional education faces for the Wheatbelt.

RDA Wheatbelt's recent submissions on the education reviews highlight the current education structure in the Wheatbelt, the challenges faced by regional schools (including students and teachers), and what opportunities/change mechanisms can enhance students' experiences.

Defence Supply Chain Project

The project's scope is set to expand to include renewables in the broader supply chain, given the transition within the Wheatbelt to include the renewables industry. Gemma Bovington and Chetan Bhatia continue to work within this project, including:

- Engaging Wheatbelt businesses and defence contractors;
- Identifying regional capabilities and aligning them with industry needs;
- Supporting businesses currently engaged in the defence supply chain; and
- Encouraging new businesses to explore defence-related opportunities.

The project seeks ongoing support from both State and Australian Governments and continues collaboration with the Office of Defence Industry Support (ODIS). By building these partnerships, the initiative aims to diversify and strengthen the Wheatbelt economy.

Housing

RDA Wheatbelt is pursuing opportunities to improve key worker accommodation across the region. Adequate housing is essential for workforce attraction and retention — particularly for major regional projects. RDAW understands that LGs require appropriate key worker accommodation to fill critical shortages in employment areas, as well as meet demand of large-scale projects set to begin in the region.

RDA Wheatbelt is:

- Engaging with Australian Government departments to identify funding pathways and future possibilities;
- Building relationships with key stakeholders; and
- Assisting Local Governments with funding proposals and advocacy support.

Local Governments are encouraged to contact RDAW for assistance in developing projects or funding proposals for housing solutions.

Local Government Funding Support

RDA Wheatbelt continues to offer assistance to LGs with funding opportunities for various projects throughout the region. Our organisation has assisted with connection-building between various industries, stakeholders and LGs, and the lobbying of Australian Government Ministers to access greater support for projects within our region. RDA Wheatbelt encourages Local Governments to contact us regarding:

- Initial proposals – discussion regarding the logistics and requirements of such undertakings to achieve maximum funding opportunities.
- Business cases – to analyse and provide feedback on completed business cases before submission.
- Funding applications – to analyse and provide feedback on funding applications before submission.

Our organisation provides this at no cost to stakeholders and ensures that funding submissions contain all necessary information and elements for assessors. If your LG is undertaking any particular project that seeks Government support or funding, please reach out to see how we can provide as much support as possible.

Regional Precincts and Partnership Program (rPPP)

The rPPP will run over 3 years, from 2023/24 to 2025/26. It is primarily focused on a partnership approach, bringing together government bodies and communities to plan and deliver regional precincts, tailored to local needs and create a shared vision in how the precinct connects to the region. Partners can be from government, First Nations groups, community organisations, regional universities, or private enterprise.

Regional precincts or ‘places with a purpose’ are user-defined geographic areas with a specific shared need or theme. Regional precincts may include business districts, neighbourhoods, activity centres, commercial hubs or community and recreational areas. They are located in renewal and growth areas in regional centres, regional corridors, regional cities, as well as smaller town centres that serve as service hubs in more remote communities.

There are two streams of the rPPP which are delivered as two separate grant opportunities:

- Stream One - Precinct development and planning: to activate partnerships and to deliver an investment-ready precinct plan.
- Stream Two - Precinct delivery: to deliver a specified project or projects as part of a precinct.

The objective of Stream One is to activate partnerships to jointly deliver precinct plans. The intended outcomes of Stream One are:

- establish partnerships comprised of relevant government entities, community organisations and businesses that have a shared vision for a regional precinct;
- deliver precinct plans that are tailored to their local contexts and based on community feedback and engagement;
- support precinct plans to become investment ready; and
- contribute to the Australian Government’s current policy priorities, including but not limited to Closing the Gap, transition to a net zero economy, Australia’s emission reduction goals, social and affordable housing, and National Cultural Policy.

The objective of Stream Two is to work with partners to support the delivery of precincts that will provide targeted benefits related to productivity, equity, and resilience for regional, rural and remote areas across Australia.

The intended outcomes of Stream Two are:

- deliver project(s) that form part of a precinct or foundational infrastructure that activates a precinct;
- develop and deliver regional precincts comprised of multiple infrastructure components, which provide benefits related to productivity, equity and resilience; and
- contribute to the Australian Government’s current policy priorities, including but not limited to Closing the Gap, transition to a net zero economy, Australia’s emission reduction goals, social and affordable housing, and National Cultural Policy.

Study Hubs

RDA Wheatbelt will again welcome the Australian Government Minister for Education, The Hon Jason Clare MP, who will be travelling over exclusively for the opening of the Northam Study Hub mid-November. The Minister has been impressed with the program's outreach across the region, having officially opened the Ellenbrook Study Hub on 3 June, which captures students from the Wheatbelt's peri-urban Local Government areas and provides access to services where they would otherwise be required to travel into the city.

With the Northam Study Hub now operational, this brings the total number of hubs serving Wheatbelt students to six:

- Regional Hubs: Merredin, Narrogin, Northam, Wongan Hills, York
- Metropolitan Hub: Ellenbrook



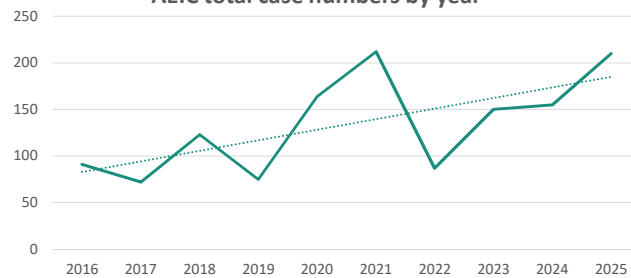

AEIC total case numbers by year



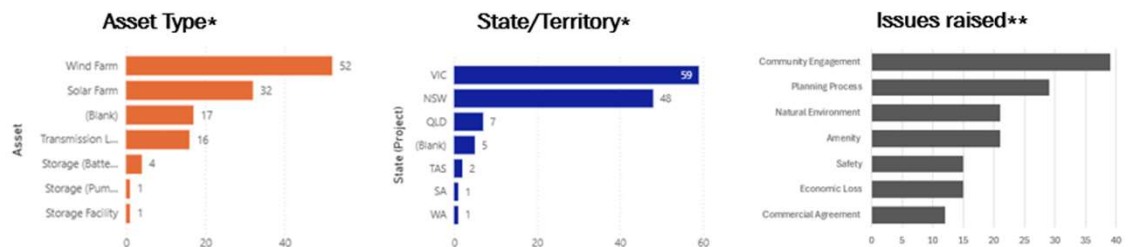

National Road, Transport and Infrastructure Congress 2025
