We have received AWARE grant funding for the State Risk Project. This funding will assist preparation of the Shire's local level participation in the State Risk project. Funding amount was \$4,000.

The ESL application for a Co-Location centre at Morangup which will incorporate SES has been successful. Funding amount is \$316,000.

Funding has been approved for a new Coondle Fire Station which will be located south of the wheat bins on the corner of Bindi Bindi Toodyay Road and Coondle West Road. Funding amount is \$277,400.
