PURPOSE

To provide information on current activities involving the Shire museums and its collections.

BACKGROUND

This update follows on from a verbal report presented at the Museum Advisory Committee meeting in February 2020.

OFFICER COMMENT

This report is on current activities – no further actions are recommended

Collections

- Transcriptions
 - New Norcia Police Occurrence Book 1878 transcription ongoing of police activities when New Norcia was a part of the Toodyay Road Board district. Continued until volunteer activity ceased at the site in late March 2020.
- Accessioning of a group of smaller items (which have been stored for a long time with the museum collections, but not included in the current database) has commenced after a review of their suitability for inclusion in

the collection. The difficulty has been the lack of information about the history of these items, but we have erred on the side of caution and for the most part have decided to formally include them as a part of the museum collection. See attached list.

- High resolution photography of museum artefacts (most of which are currently off display due to the Newcastle Gaol restoration) continued until volunteers ceased work at the site in late March 2020.
- Maps and plans from the museum collection which were suitable for handling were scanned using the new plotter/scanner/printer at the Shire Administrative office.
- After an inspection at the museum workshop by Senior Constable Greg Kingston of the Licensing Compliance Unit in March 2020 we were informed that, under current regulations, the firearms in the museum collection are subject to changed storage and display conditions.

This affects the six historic cap action firearms dating from the nineteenth century that are currently listed on the Shire's general gun license. (A few years ago, the Shire was obliged to transfer these firearms to the general license because, as a local government authority, it was no longer allowed to hold a Collectors License.)

While the historic firearms have been appropriately deactivated this is now required to be permanent by pouring lead down the barrels, which will drastically reduce the firearms' historical integrity and value. However, if this is not done, they cannot be placed on display, nor can they be stored with the museum collection.

Comment invited from Museum Advisory Committee members on this matter about appropriate way of moving forward.

On site Newcastle Gaol precinct

- 1907 lockup, Wicklow Shearing Shed & Newcastle Police Stables closed to public visitation between 22 March and 5 June per WA Government directive.
- White ant infestation was discovered in one pine built-in display case in one of the front rooms of the Newcastle Gaol. This happened over several weeks during the site shutdown and has now been treated.
- Restoration project: painting of interior walls of front wing (warder's quarters) and side wing (prisoner's day room & kitchen) commenced towards the end of May 2020, after the site had been shut down in late March. Heritage advisor consulted in regard to appropriate paints, colours and fillers.
- On Saturday 6th June, the cell wing of the gaol was re-opened (with Covid-19 safety plan in place), along with the Newcastle Police Stables and Wicklow Shearing Shed for public visitation. Public advised displays in the cells were a "work in progress", as the larger museum items were still in storage in the container on the opposite side of the road. Because the remainder of the site is being painted during the weekdays (and is still empty of furniture and artefacts), public access can only be accommodated at weekends

Connor's Mill

 Public visitation to site ceased between 22 March and 5 June per WA Government directive. Mill re-opened (with Covid-19 safety plan in place) on Saturday 6th June when the WA Government's Stage 3 Roadmap to Recovery strategy was launched.

Promotion

- Articles about the museum, activities and heritage subjects are included in the monthly Shire newsletter.
- The Toodyay Herald continues to publish photographs from the Shire Collection on page 4
- The Toodyay Museums Facebook group continues to promote the activities of the museum to those who have joined. During the height of the lockdown at both museum sites (end of March to beginning of May) two posts per day were made to assure the public that important work on caring for the museums and their collections were continuing behind the scenes.
- The toodyaymuseum Instagram page continues to post photos about our two museum sites. Daily posts were made during the height of the lockdown at both museum sites
- Proposed ABC Midwest interview with Samille Mitchell about Connor's Mill 15^{0th} anniversary year on 25th March was cancelled due to pandemic.
- Time-lapse images recorded during the re-shingling of the Newcastle Gaol were compiled into two videos and posted on the Shire websites for viewing in Mary.

Community engagement

Volunteer project to recover and sell old shingles is ongoing.

Displays

- After access to gaol site resumed (following conclusion of restoration portion of project managed by CLPM) work to reinstall updated displays in cell wing – including Moondyne Joe, Dorizzi memorial cell, growing up in Toodyay, textiles & trades – was undertaken.
- Three separate online exhibitions have been launched on the Shire websites, based on research undertaken for major temporary exhibitions held in the past few years and the Newcastle Gaol Museum. Two were launched in April, titled "Not Just Barefoot and Pregnant... but much, much more!" and "Remembering Them" in time for ANZAC day. In May a third exhibition titled "Hurting and Healing – health care in Toodyay" was launched.

Public programs / public engagement

 Connor's Mill 150th anniversary year program of events suspended until further notice. Only the February launch event went ahead. Slide shows about some of the various eras of Connor's Mill's history have been produced and uploaded to Shire websites (flour milling & power generation) and played on a screen pointing out the front window of the

mill for passers-by to view. Acknowledgement to Beth Frayne for her work in this area.

- All tour bookings for the mill and gaol sites suspended until further notice
- Collaborated with Paul Morgan Designs and The Bookshed to supply historical photos from the museum collection for the Alma Beard Medical Centre's reception fit-out honouring Toodyay's history.

Educational material

 Five binders of hard copies of our online lessons (specially developed for schools to use and specifically relating to our museum sites) were left at Toodyay District High School in March 2020 for teachers to read in their staff room.

PURPOSE

Following the audit of the museum collection in 2019 a collection of items were identified that were being stored with the museum collection but had not been included on the current museum database.
