That Council endorses the contract conditions subject to clarification of Clause 5A to reflect the intent below:

- Clause 5A The buyer and the seller are to equally share the tendered cost of completion of the road and the associated drainage, as is cross hatched on the attached plan being Annexure B, taking full account of the existing drainage already installed by the seller. This requirement will be achieved as follows:
 - (i) The buyer will invite public tenders for the completion of the road and the agreed contribution will be based on the cheapest compliant tender from a WALGA preferred supplier;
 - (ii) The existing drainage on that road cost \$27,000; and
 - (iii) On completion of the road construction the seller will pay to the buyer, within 30 days of the invoice, an amount calculated as a one half share of the tendered cost of the road and drainage minus the cost of the drainage already installed – that is 50% of {(i) + (ii)} minus (ii).

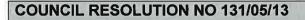
Cr McCann departed Council Chambers at 8.40 pm.
