1931 School Bus Crash Memorial

6 August 2018 marks 87 years since the Coondle-Culham school bus, packed with 34 students, was hit by a train. Five boys died and 12 more children were injured, several seriously.

The impact of this terrible accident is still felt today by descendants and family members of those involved.

In 1932 a memorial tablet was presented to the Toodyay State School by members of the Toodyay RSL. This tablet remains on display at the Toodyay District High School today. While valued, it is less accessible by members of the general public.

In 1994 a brass plaque was produced, commemorating the planting of a native garden by Toodyay District High School students in memory of the

children killed in the crash. For many years the plaque was located by the railway station steps until its mounting deteriorated. In 2012 it was moved to the museum collection for preservation. Its absence was felt by the community.

On 17 July 2018, on a glorious winter day, we were touched to unveil a new memorial, very near to where the collision actually occurred. The plaque is affixed to a stunning piece of Toodyay stone placed within a newly planted garden. "Forever in our memory"

On a positive note.....

As we finalise our budget for the coming year it is good to reflect on some of our successes:

- The Commonwealth has awarded \$4.7 Million funding towards the new Sport and Recreation Precinct most notably the new Pool!
- Lotterywest has provided \$197,000 towards the cost of restoring the Newcastle Gaol Museum;
- DFES has provided 2 grants \$277,000 towards the new Coondle Nunile Fire Shed and \$316,000 towards the cost of upgrade of the Morangup Fire Shed to accommodate the SES Unit;
- DFES has fully funded a Bushfire Risk management Officer for the next 12 months.

There was a lot of hard work involved in making the case for these grants, and we will be seeking more. I congratulate all the staff involved in securing these funds and of course the funding agencies. It will be a busy year delivering these projects for Shire staff.

Rosedale Village - OFFICIAL OPENING

Hon Darren West MLC officially opened Rosedale Village Stage 1 in Toodyay on Monday, 6 August 2018. Rosedale Village is a complex of 9 new Independent Living Units owned and operated by Butterly Cottages Association Inc., a not for profit community based aged housing provider. Butterly Cottages was established in 1976. The addition of the 9 new units will increase to 21 the total number of independent living units managed by Butterly Cottages.

Butterly Cottages provides the opportunity for older residents to stay in Toodyay, continuing to enjoy the community and the belonging that comes with it, and to live in quality affordable housing. Butterly Cottages is not part of a larger corporate entity or regional group. Its singular focus as a community led and community run affordable housing provider for older residents is part of the secret of its success.

Rosedale Village was part of a larger regional project managed by the Shire of Toodyay and part funded by Royalties for Regions. Toodyay's part of that project also involved significant financial investment by both the Shire of Toodyay and Butterly Cottages. The result is a credit to everyone involved.

The regional project was managed by the Shire of Toodyay. In addition to the 9 units in Toodyay there were 2 units in each of Calingiri and Bolgart in the Shire of Victoria Plains and 4 units in the Shire of Goomalling.

The grant agreement for the Royalties for Regions funding was signed on 13 April 2015. Combined grants contributions to the project totalled almost \$1.3 million for Toodyay and \$3million across the region. The cash contribution from Butterly Cottages was \$750,000 and in addition to managing the project the Shire contributed \$600,000 cash

Rosedale Village is a great example of State and Local Governments working together with the community to produce much needed community infrastructure.

\$316,000 Grant for Emergency **Services Facility Upgrade**

The Shire of Toodyay was recently awarded a \$316,000 grant to formally co-locate the Toodyay SES at the Morangup Bush Fire Brigade Station.

Toodyay SES was formed in 2014 with one vehicle. Since then the membership has grown and additional vehicles welcomed by the unit which has warranted the application for upgrade.

The upgrade will provide additional vehicle bays for SES vehicles and an upgraded meeting/training/incident control room.

Of course, being co-located means that the Morangup Volunteer Bushfire Brigade will also benefit from the upgrades. The grant results from Emergency Services Levy funds distributed by DFES under the Local Government Grants Scheme. This grant is in addition to a grant received for a new facility for Coondle-Nunile Volunteer Bush Fire Brigade in the previous funding

Local Government Act 1995 review update

For the first time in more than 20 years, the Local Government Act 1995 is being reviewed to modernise the Act so that it meets the current and future needs of the Western Australian community and local government sector.

The engagement period for phase one of the review closed in March 2018. Approximately one - third of local governments provided a submission to phase one of the review. These submissions were a valued input to the review and directly informed the preparation of recommendations.

Announcement of phase one reforms

On 1 August 2018, the Minister announced a suite of phase one reforms which have been developed in consultation with the local government sector and broader community. This is a significant milestone in the review and will strengthen public confidence in local government and the sector's capability to deliver for the community.

Key reforms to be implemented under phase one include:

- universal training for candidates and council members
- better standards of behaviour
- improvements to CEO recruitment and performance review
- simplified gift framework

The reforms also have identified out of date provisions for removal that will increase local government efficiency.

Local Government Act 1995 review: phase two

Phase two of the review is underway. In July 2018, topic forums were held in Leederville. More than 100 people from local government and the broader community attended the nine forums, either in person or by Skype, following more than 150 expressions of interest. The topic forums have informed options to be considered in discussion papers that will be released in the coming months.

These discussion papers will canvass options in diverse areas such as community engagement, elections, rates and financial management.

Next steps

Drafting of the legislative reforms for phase one of the review will now commence to prepare a Bill for Parliament to amend the Local Government Act 1995.

With phase two of the review underway, it is worth reiterating that this is a once in a generation opportunity for the sector to shape the future of local government in this State. More opportunities to get involved will be announced shortly.





I have not been able to wipe the smile from my face after hearing the Building Better Regions the Honourable Christian Porter. But the first question asked is - what does this entail? Firstly a pool. Second question, can we have a heated covered in pool? Claim 1 There has been almost 5 years of recession.

tion on record in 2016-17 (of -2.7%).

Claim 2 Household debt is growing at its fastest rate on record with a ing and fire prevention in that year alone. typical family's debt now at 200 per cent times their annual income.

The Truth Analysis of debt levels in Toodyay indicate a higher proportion of people in Toodyay with low mortgage repayments and lower proportion of people with high mortgage repayments compared to WA in total. The same is evident amongst renters.

Claim 3 But as the council's recent rates comparison review by accountants Moore Stephens shows, Toodyay has ostensibly priced itself out of this market with shire rates now higher than most other comparable shires in Western Australia

The Truth The review said nothing of the sort. The review indicated that Toodyay for GRV had the second lowest rate yield per property, and \$100 (4.9%) per property less than the average. The yield per property for UV is 9.7% above the average, and the third highest of the 6 in the comparison group. It also identified that Toodyay's operating surplus was barely sufficient to cover capital needs.

Claim 4 Toodyay is one of WA's more expensive shires for rates.

The Truth That is not supported by the evidence in the report. The report showed the average GRV Rates per property was higher in Chittering, Denmark, Katanning and York. Only Waroona raise less per property and they have access to mining rates.

Claim 5.. The State being in recession for most of the past five years.

The Truth WA had only one year of recession, 2017-18. Gross back. State Product grew by 6% in each of 12-13 and 13-14.

Claim 6 ... rates paid by Toodyay residents far beyond that paid by those living in similar shires across Western Australia.

The Truth Not supported by the evidence. Toodyay is one of the lowest.

In May 2018 Cr Benjamin Bell published a column in the Toodyay Claim 7 the amount of money the shire spends on community ser-

The Truth Spending on community amenities increased by 12% between 2013 and 2017. In the same period cash backed reserves (savings for future facilities) increased by \$1.25 million, or 67%.

The Truth Gross State Product is expected to rebound to 2.5% in Claim 8 The shire's spending on law and order (and fire prevention) last 2017-18 and 3.25% in 2018-19, following the first annual contracy year of around \$400,000 is \$100,000 less than it spent in 2013 and a long way short of 2012 when the shire spent almost \$1 million on polic-

> The Truth Spending in 2012-13 and 2013-14 included capital works on access and egress tracks, part funded by the Commonwealth.

Claim 9...the shire's wage bill, which has increased by around \$1.2 million – or 140 per cent – since 2013.

The Truth Total employee costs have increased by 35%, and this has included strategic decisions like employing an Environment Officer, Reserves Management Officer, Mechanic, Apprentice and bringing sport and recreation in house.

Claim 10...councillors' fees which have doubled over the same period.

The Truth The Salaries and Allowances Tribunal significantly increased Councillor remuneration in 2013. The increase since then has been 14%. Council adopted a policy in 2007 to pay Councillors only 80% of what is available. That has not changed.

Claim 11 Since 2013 the development of the proposed recreation reserve has cost ratepayers a very surprising \$5.5 million.

The Truth The actual breakdown of costs is \$2.79m spent (not \$5.5M). The \$2.79 includes the purchase of the land at \$1.68M.

Claim 12 Should the council have any issues with the budget, it is sent back to the CEO for refinement until such time as it meets the satisfaction of the council. Once the council approves the CEO's draft budget, it is presented to the Toodyay community for consideration and feed-

The Truth The budget is always a Council budget and the budget is set by Council. Council workshops the budget and changes are made by consensus prior to formal adoption by Council

JUST THE FACTS cont'd...

Claim 13 A public session or meeting between council and ratepayers
