



Let your voice be heard

Making a PUBLIC SUBMISSION to Council

It's not as hard as you think!

Do you ever wonder how you can let Council know that you agree and support them or that you do not agree with them and would like your opinion heard?..... Well you can!

At each Council Meeting, there is provision whereby any member of the public can stand up and 'make a submission'. Basically this means that you can stand up during a Council Meeting and read out your submission or opinion on the matter you wish Council to take note of. A submission is different to asking a question during Public Question Time. A submission being presented at a Council meeting must be relevant to an agenda item for that meeting.

It is best, and preferred, that your submission is lodged with the CEO prior to the Council Meeting - usually by midday on the day of the meeting. Simply complete the Public Submission Registration Form and send it to the office of the CEO.

At the meeting you will be invited to present your submission by the Presiding Member, which is usually the President. You will stand at the lectern and state your name and address and identify whether you are a ratepayer or resident of the Shire. You can then read out your submission - you will have 5 minutes.

'Submissions' is a formal part of the Council meeting Agenda and the *Shire of Toodyay Standing Order Local Law 2008* prescribes the manner in which submissions are made.

Newcastle Gaol re-opening cell wing only on weekends 10am – 3pm

On Saturday, 6 June 2020 we took up the challenge to partially re-open the Newcastle Gaol in celebration of entering Stage 3 of the WA Government's Road to Recovery strategy. We had actually already re-installed some of the displays in the cell wing before the enforced closure of the site in March.

Some furniture and large items still remain packed away in the container opposite the Gaol, so the displays have some finishing touches to be done. Our grateful thanks to Barry and Michelle for enabling the re-opening, as there are a number of additional duties involved to comply with safety guidelines for operating during a pandemic. At this stage we are only able to manage to have the Gaol open on Saturdays and Sundays.

Because the Gaol is only partially open, entry is currently through the side door of the courtyard which is difficult for mobility impaired folk. Our apologies for this. Elsewhere on the site, painting of internal walls in the front wing and "courthouse" is currently being undertaken. We are also repainting a couple of external areas along the front - including the bars and wooden shutters - which will subtly lift the appearance of the front façade without detracting from its historic integrity.

After painting is finished and the container is unpacked, then the additional items being stored in the museum workshop and Stables can also be moved back across the road, information panels put back up and the audio-visual components reinstalled. We are hoping, at this stage. for all of this to be finalized by the end of June or perhaps in early July. Please be rest assured, we are as anxious to fully re-open the Gaol as you are. Check our Shire websites and Toodyay Museums Facebook page for up to date information on this timeline.



The Toodyay Visitor Centre doors are now open. Physical restrictions apply and we kindly ask that they are adhered to. We have had a couple of busy weekends which is great to see. Connor's Mill is also open and we have had many eager tourists explore the museum already.



False, as much as we wish it were true. Rather than relaxing with the latest Nora Roberts, we're kept busy issuing, returning and renewing loans; shelving; prepping new stock; processing inter-library loans;





Libraries are whisper-only zones, so make sure you keep the noise down at all times durina vour visit.

Granted, some libraries do encourage "inside voices" (especially in dedicated reading or study areas) but feel free to speak at a normal volume within Toodyay's walls - we like to think of ourselves as a livelier kind of library. Legionnaires' Disease

We are being reminded to maintain cooling towers and flush other water systems that may not have had regular use recently due to the closing of buildings due to COVID-19 in order to prevent Legionnaires' Disease . Water systems include showers, emergency eye baths, spas, fountains and ice machines.

The warnings follow five cases of Legionnaires' Disease notified to the Department of Health in metropolitan and rural Perth. Legionnaires' Disease is a serious and sometimes fatal form of pneumonia caused by breathing in Legionella bacteria in very fine droplets of water (aerosols).

WA's A/Executive Director, Environmental Health, Dr Michael Lindsay, said no common source of infection between the cases has been confirmed, however the investigations are ongoing.

"It is a timely reminder that building operators need to properly maintain cooling towers and other water systems.

"Many buildings have experienced significantly reduced occupancy or been closed completely as a result of COVID-19," he said.

"When cooling towers or water pipes have not been in use for an extended period, stagnant water can create opportunities for Legionella bacteria to grow, leading to an increased risk of an outbreak of Legionnaires' Disease when the systems are switched on again." The Department recommends building managers seek advice from a water treatment provider to ensure correct maintenance of their

cooling towers and water systems.

Legionnaires' Disease symptoms include fever, chills, a cough and shortness of breath and may lead to severe chest infections such as pneumonia.

Early symptoms of Legionnaires' Disease can be similar to symptoms of COVID-19, so it is important to seek medical advice as soon as possible.

Burn season is the perfect time to take action on your own property to stop the spread of **European house borer!**

European House Borer (EHB) is a pest of seasoned dry pinewood, most often found outside in dead pine trees, dead parts of living pine trees, and in pine logs and debris. The cooler weather is a great opportunity to make your house and property as unattractive to EHB as possible, by fully burning (or chipping) all unwanted/dead pine wood which could host this serious pest. The Department of Primary Industries and Regional Development (DPIRD) is working with the community to stop the spread of this serious pest.

If you do decide to burn, the most important thing is to do it safely. Your first step is to check your local government website for their specific burn related guidelines and permit requirements. If unsure, ring your local government to talk to a Fire Officer for advice.

It is a good idea to register your proposed 'hazard reduction burn' with the Department of Fire and Emergency Services prior to lighting (on 9395 9209) in case a helpful member of the public sees smoke and thinks it's a bush fire.

Registration is required whether you're running a large cattle property, grazing a few sheep on a small landholding or you have a pet pig, goat or alpaca.

Being able to trace livestock movement helps us manage disease outbreaks, boost consumer confidence in our livestock product and protect the health of the livestock industry.

Whether your farm is big or small, all Western Australian livestock owners have a role in keeping our produce clean, safe and in-demand.

Correct identification of cattle, sheep, pigs, goats

and alpacas supports traceable produce, boosts consumer confidence, keeps the door open to business and enables disease management. In coming months the Shire of Toodyay will be conducting random registration inspections.



TOODYAY DIRECTORY

RESERVE REPORT by Greg Warburton

Recently, two important historical sites in Toodyay have seen improvements completed which have added value and interest to our rich heritage.

Most people would have glimpsed Ringa Railway Bridge as they travel along the main road but perhaps are not all are aware of its significance. The bridge was originally constructed in 1887 on the Clackline - Newcastle (Toodyay) Railway which was a spur line off the Eastern Railway to Kalgoorlie and part of the State's narrow gauge system. A railway siding was located near the bridge and also derived its name from the Ringa locality.


For the district this rail line was a major infrastructure project that enabled the expansion of agriculture and other economic developments.

Refurbished in 1950 then decommissioned in 1968 Ringa Bridge was handed over to the Toodyay Shire Council by the then Western Australian Government Railways. In 1998 it was classified by the National Trust Western Australia due to its historical importance.

The bridge stands on Shire of Toodyay Reserve and the original railway formation is designated as Crown land which can be traced from Coorinja Winery south to the original junction at Clackline.



Another site of great historical significance is Syred Cottage in Bejoording. This building dates back to the 1850's and bounds onto shire reserve 6847 which was an historical watering place for livestock and part of the original Bejoording Farm. The cottage featured a distinctive double post and rail fence known as a "Harper Fence". This style of construction is named after Toodyay's famous pioneer, explorer, pastoralist, politician and newspaper proprietor Charles Harper. Over the years the fence had collapsed but thanks to the extraordinary efforts of a descendant of William Syred, Bob Sutcliffe it has been beautifully restored thus preserving an important example of this pioneer ingenuity. Ringa Bridge is one of the largest wooden railway bridges in Western Australia and a significant historical landmark. The site makes a wonderful place to visit. Not only is the structure imposing but it straddles the picturesque Harper Brook.


The Shire has installed new safety barriers and signage along with bollards and a picnic table. An interpretive plague has been installed that tells the story of Ringa Bridge along with its fascinating connection to the famous convict William Sykes (1826 - 1891).
