The Shire of Toodyay is currently in the Restricted Burning Period. Permits are required and are currently only being issued for the burning of stubble and chaff for crop preparation purposes for Primary producers. Application for permits must be made via the Shire of Toodyay's website. Holders of permits must comply with all permit conditions which include (but not limited to) restrictions/requirements around burn notifications, minimum supervision & firefighting resourcing. Please note permits will not be issued for the burning piles or timber. During this restricted burning period the Shire of Toodyay will be trialling the issuing of permits for bona fide Broad acre stubble operations, for extended periods up to 28 days to reduce re-application requirements for farmers with large operations.

Please be advised the Restricted Burning Period may be extended beyond April 30 dependant on weather conditions.

This year we are celebrating the sesquicentenary of Connor's Mill. It is 150 years since Daniel Connor had a steam driven flour mill built on the main street of the township of Newcastle (later re-named Toodyay).

In recent years this iconic building has been recognised for its significance. In 1977 it was classified by the National Trust of WA, it was placed on the Permanent Register of the National Estate in 1980 and in 1998 included as a Category One (highest level) building on Toodyay's Municipal Heritage Register. In 2006 it was given Permanent Entry in the State Register of Heritage Places.

The mill building has fulfilled several different functions over its life - as a flour mill, a power station, a tourist information centre and a museum. Over the coming year we are planning a series of activities at the mill to celebrate its long history. Many activities are joining in with existing events happening in town.

Our first event for the year happened at the end of February. We were pleased to welcome back many folk who had been involved with the Toodyay Tourist Centre which operated out of the ground floor of the mill from 1975 to 2000. Our Connor's Mill 150th anniversary souvenir booklet was launched as well as a slide show about the mill's history put together by Beth Frayne of the Toodyay Historical Society. The first era (flour milling) of the mill is now featured on a presentation running throughout out the day on the ground floor. As the year progresses more historical eras will be added to the slide show.

TOODYAY'S NEW SPORT & RECREATION PRECINCT

This project has been many years in the planning and is now becoming a reality for the Toodyay Community.

Thursday, 6 March marked a milestone event with the final concrete pour of the swimming pool. Thank you to our Builders, ADCO for hosting this event.

Key Activities Undertaken during February:

- · All civil siteworks bench levels, including civil drainage routes were completed.
- The main carpark areas have been levelled, formed up and proof rolled. Road base installation and compaction has commenced.
- The concrete pours to the Swimming Pool, Balance Tank and Backwash Tank were completed.
- Recreation levels surrounding the Aquatic Centre were finalized.
- The Aquatic Centre steelwork installation was completed and roof installation commenced. Aquatic Centre internal masonry blockwork walls are progressing.
- All major in-ground services installation have been completed.

- The Community Pavilion & Changerooms brickwork external walls and internal masonry block-work walls were completed.
- The Community Pavilion & Changerooms roofing were completed.

The build is really taking shape now and project staff are very excited how it is progressing.





President's Pen

This month I wish to report on progress with the Sport and Recreation Centre. As you will be aware, Council last year awarded ADCO the construction contract for the Centre at a price of approximately \$14 million.

Work commenced at the end of last year with an estimated practical completion date of mid-May this year.

In the course of the earthworks it was found that there was more rock than anticipated under the pool site which needed to be removed. In fact the amount of rock was more than twice that allowed for in the contract. The extra time involved in removing the rock (blasting had be carried out after school hours) and inclement weather (mainly excessive heat) has meant that the practical completion date has been pushed back to the end of July. After taking into account the cost of removing the extra rock, amounts allowed for contingencies and some reduction in provisional sums, it is anticipated that the project will come in on or under budget.

All civil site works have been completed and the concrete shells for the pools have been poured. The framework walls and roof of the Community Pavilion have been completed and roofing for the Aquatic Centre will be installed this month.

Councillors and other guests were invited to an inspection of the works by ADCO on 5 March and were impressed with the scale of the project and the progress which has been made. I have no doubt that the Centre, when finished, will be a facility of which the Toodyay Community can be justly proud and which will be a credit to all those involved.

Thank You Letter Received

On behalf of the Toodyay Famers Market (TFM) Association I am writing to thank the Shire of Toodyay for their ongoing support.

The recent funding from the Shire was greatly appreciated as it allowed the purchase of games for children, power cords and a power box. The Market would not be possible without the ongoing support of the Shire, through the provision of the space, electricity and waste and recycling services and the ongoing promotion of the market. Also having the Shire stall at the markets, and Councilor's and staff in attendance, enhances the Markets and gives the community an opportunity to talk to Shire representatives in an informal setting. In particular, Deb Andrijich and Tobie Prater, have been consistent supporters of the market and their efforts are greatly appreciated by the Committee.

At the December market the TFM Committee undertook a survey of attendees to gain an understanding of who is attending the markets and what they value about it. Result showed, of those surveyed, 76% were Toodyay local residents with many attending the markets every month. Those surveyed said that they valued the friendly atmosphere of the markets, the opportunity to support local artists and businesses and the social opportunities at the market to meet and talk to people in the area.

The Market will be having its 5 year anniversary in April of this year and the ongoing support of the Shire and Community continues to make the event a focal point for not only the residents of Toodyay but also local community groups, such as the Toodyay Men's Shed, RSL and Lions Club. The markets is a **monthly** opportunity to bring the community together, promote local initiatives and produce and add to the Toodyay economy. Over the coming year the TFM Committee intends to build on the existing success of the markets, work to further engage additional Toodyay community members and volunteer groups and to attract more visitors from other areas to Toodyay.

Again, on behalf of the TFM Association I would like to thank the Shire of Toodyay Councillors and fantastic staff for their ongoing support of this important community initiative.

Keeping your cat safe and happy at home means providing for all their needs, including many that may previously have been met by being outdoors. Meeting these needs in other ways requires forward thinking and a little imagination and commitment. But you needn't go it alone: we're here to help explain how you and your cat can live at home together in harmony. Why should I keep my cat contained?

By keeping your cat safe at home you will be:

- reducing the risk of them getting sick, being hurt or dying in an accident \rightarrow
- enjoying more quality time together \rightarrow
- reducing the risk they will stray and be lost or impounded by the council \rightarrow
- minimising the risk they will harm or kill other animals \rightarrow
- preventing them from interacting with undesexed roaming cats \rightarrow
- \rightarrow avoiding problems with your neighbours
- giving them a better chance to enjoy a longer, healthier life. \rightarrow

The Risk of Roaming

Keeping your cat at home helps protect them from an increased risk of disease, injury or death from:

- \rightarrow being hit or run over by a car
- being attacked by a dog \rightarrow
- fighting with other neighbourhood cats \rightarrow
- acquiring a serious infection, such as Feline Immunodeficiency Virus (FIV) \rightarrow
- eating toxic plants or poisons (e.g. toxic chemicals, poison baits \rightarrow

RANGERS

The Shire of Toodyay in recent times has experienced an increased number of reports and Ranger attendance for stray dogs. Under the Shire of Toodyay Dogs Local Law 3.1(1) it is stated an owner of a premises on which a dog is kept, must ensure -

- The fence used to confine the dog and every gate in the fence is of type, construction and condition to contain the dog at all • times from passing over, under or through it.
- That every gate or door in the fence is closed at all times when the dog is on the premises and is fitted with a proper latch or ٠ other means of fastening it.

LIVE STOCK CONTROL We are also experiencing an increased number of reports and Ranger attendance of livestock on the roads. Owners are responsible for maintaining adequate fencing and taking other measures to prevent their stock from wandering.

WHATS COUNCIL BEEN UP TO THIS MONTH?

An Ordinary Council Meeting (OCM) was held on 25 February 2020. 15 community members were in the public gallery.

The Agenda Briefing had been held one week prior to give Councillors the opportunity to digest the Agenda and to ask questions in relation to it.

Decisions made at the OCM were as follows:

- Council chose to not endorse the Terms of Reference for Committees of Council nor the Advisory Groups Policy.
- Council resolved to make a request under section 58 of the Land Administration Act 1997, to the Minister for the permanent closure of a portion of an unconstructed portion of public road: Polygon Number 11528562, Land ID: 3559944, Land area: 4,037.46m².
- Council approved two new fees to be included in the 2020/2021 Schedule of Fees and Charges in relation to (1) Application to breed cats and (2) a variation of the residential design codes and local planning policy where the estimated cost of the development of a cat breeding place would be.
- Council granted an amendment to the development approval for the proposed Redevelopment for Civic Use at the site of the former Shire of Toodyay Parks and Gardens Depot located at Lots 3 & 6 Clinton Street in Toodyay. This means that the Toodyay RSL can move forward with their plans to build their club rooms on the site.
- Council deferred an item regarding North Street until the CEO undertakes a formal community consultation process regarding the construction of the temporarily closed section of North Street for a period of not less than 35 days. This item will be going back to the May 2020 Council Meeting.
- Council noted as being paid payments listed and presented for the month of January 2020.
- Council accepted the monthly Financial Statements, • Outstanding Rates and Outstanding Sundry Debtors Information for the period ending 31 January 2020.
- Council received the Records Management Performance Audit Action Plan – Status Report.
- Council adopted, with an amendment, the HR.4 -Managing Leave Entitlements Policy.
- Council adopted the 2020-2025 Disability Access and Inclusion Plan (DAIP).

- Council adopted the REVISED Policy M.3 Members Sitting Fees and Reimbursable Expenses, subject to amendment to the REVISED Policy, as follows:
 - Each Councillor shall receive an annual Meeting ٠ Attendance Allowance of 75% of the maximum amount of the annual allowances.
 - The Shire President shall receive an annual Meeting Attendance Allowance of 60% of the maximum amount of annual allowances.
 - The Shire President shall be paid in addition to the Meeting Attendance Allowance, a President's Allowance of 60% of the maximum amount of annual allowances.
- That Council adopted Policy M.9 Attendance at Events, as amended
- That Council adopted Policy M.4 Continuing Professional • Development.
- Council did not adopt their Council Forum Policy but they did decide that they would introduce a Concept Forum to be scheduled to follow the Agenda Briefing at 4.00pm."
- Council adopted the attached Compliance Audit Return for the period 1 January 2019 to 31 December 2019 pursuant to Regulation 14(3) of the Local Government (Audit) Regulations 1996.
- That Council noted the significant adverse trend of the Asset Sustainability Ratio and the Operating Surplus Ratio
- Council requested that the light vehicle fleet replacement, HR7, Live Streaming, Purchasing Policy and M1 Policy be brought to the March meeting.




No smoking outside enclosed public places Legislation changes (2019)

Smoking is not allowed within 5 metres of a public entrance to an enclosed public place such as a food business and within 10 metres of air conditioning intakes.

Existing restrictions on smoking inside enclosed public places mean that smokers are required to smoke outdoors. Problems arise when smokers cluster around building entrances and exits. and near air conditioning intake vents to smoke. People entering and exiting the building are exposed to environmental tobacco smoke (ETS) and there may be problems with smoke drift into indoor smoke-free areas.

These restrictions reduce exposure of the public and employees to ETS, minimise the risk of smoke drift, and contribute to the de-normalisation of smoking in the community.

Timely reminder to replace asbestos roofing

WA Health is urging Western Australian homeowners to replace - not repair - their old asbestos roofs. Asbestos Awareness Week was a timely reminder that the asbestos cement sheeting commonly used in roofs, fences and cladding of older homes across Perth and regional WA towns is now at least of 30 years old and nearing the end of its useful life.

Asbestos fibres are hazardous to human health and breathing large amounts of fibres over a long period of time increases the risk of developing asbestos-related diseases including lung cancer, mesothelioma and asbestosis.

WA Health's Acting Environmental Health Executive Director Dr Michael Lindsay said of all asbestos building materials, roof sheeting was usually in the poorest condition as it is directly exposed to sun, wind, rain and hail, and often damaged by moss and lichen that grows on its surface.

"As asbestos roofs age they weaken, leading to the potential for breakage and even collapse," he said.

"Asbestos fibres loosen and blow away and can get trapped in soils where roof water drips on or flows to the ground.

'They can even accumulate in the loft-space within the building."

Dr Lindsay said while WA Health provided advice on safe methods for maintaining asbestos roofs, replacement was the preferred option.



"Cleaning and coating your roof is an expensive, and ultimately, short-term solution," he said.

"Over time, asbestos roofs become brittle and more prone to damage and asbestos contamination spreading from any damage can lead to high clean-up costs, which may not be covered by your household insurance."

Dr Lindsay reminded homeowners they should never use power tools or pressure cleaners to repair or clean an asbestos cement roof.

'This can generate large numbers of free, respirable (breathable) asbestos fibres that can contaminate both your property and properties nearby."

In addition, Dr Lindsay said tradesmen might refuse to work on asbestos roofs and they might not be strong enough to support TV aerial, satellite dish or solar panel installation.

"All good reasons to replace your asbestos roof as soon as practical," he said.

WA Health strongly recommends all asbestos roof sheeting is removed and safely disposed of by a WorkSafe-licensed asbestos removalist.

Removed asbestos cement products are a controlled waste and must be wrapped, transported and disposed of in an approved manner.

Paint Toodyay REaD

In March 2020 the Toodyay Early Years Network is launching the Toodyay Paint the Town REaD project!

The project aims at highlighting the benefits of early literacy skills in young children.

A child's brain does most of its critical development in the first three years of life. A baby's brain doubles in weight in the first year, tripling by age three. Every time we read, talk, sing and rhyme with our children their brain connections grow. Reading helps children to develop good communication and comprehension skills. When a child is read to daily, their early literacy skills develop and their imagination grows. A love for reading is a gift that will last a lifetime.

The project will start with an egg which will make its way around our community including the school; the more it is read to the more it will grow! The eggs journey will be recorded in a special book and regular updates will be on our Toodyay Early Years Network Facebook page.


When the egg has reached full size we will celebrate with the hatching of our reading mascot! I wonder what it will be

2019 Aussie Backyard Bird Count results

The data collected by these citizen scientists plays a vital role in providing important information to BirdLife Australia. We know more about our threatened birds than we do about our common backyard birds and the Aussie Backyard Bird Count helps to fill this knowledge gap, as well as increasing our understanding of Australian bird species that live where people live. The Aussie Backyard Bird Count also helps raise the profile of bird species throughout Australia, highlighting their importance and promoting a national passion for Australian birds. Each year this natural passion is confirmed, with the Aussie Backyard Bird Count attracting significant interest from the public eager to be involved and help contribute to our growing knowledge of Australian birds. The next Aussie Backyard Bird Count will take place from 19 - 25 October 2020.

The following statistics relate to the Shire of Toodyay region during the Aussie Backyard Bird Count that ran from the 21 to 27 October 2019: 22 observers participated in the bird count - A total of 2,018 individual birds were observed and recorded during the week - 78 bird species were recorded.


