PUBLIC NOTICE PROPOSED HEALTH LOCAL LAW 2017

The Shire of Toodyay proposes to make a local law relating to local govern-

The purpose of this local law is to regulate, protect, and manage public health within the district

The effect of this local law is to protect public health. Some activities are permitted only under a permit or by determination and approval by the Shire of Toodyay and some activities are restricted or prohibited. Offences have been created for negligence of public health within the district.

The **justification** for the local law is to provide:

- Enforcement options for issues that previously are unable to be dealt with by the Shire's authorised officers under the Health (Miscellaneous Provisions) Act 1911 or its subsidiary legislation.
- For clear breaches of public health matters that were previously dealt with under planning legislation and policies such as animal control and nuisances. The Building Code of Australia cannot be applied retrospectively in some instances and therefore fit out requirements for lodging houses or maintenance of dwellings would not be able to be enforced.

This local Law will be able to capture any issues that may have previously been unable to be dealt with by the Shire.

A copy of the proposed local law may be inspected at or obtained from the Shire's Administration Office between 8.30am and 4.30pm Monday to Friday, and at the Toodyay Library during normal opening hours.

The concept of a mural in Toodyay was first presented to Council in September 2016 by Mr Greg Warburton, Chairperson of the Toodyay Tidy Town Committee. RESPONSIBLE DOG OWNERSHIP

Many of us enjoy the company and love of our dogs. They can be the highlight of our day as we head home from work, but they are also a big respon-

It is a dog owners responsibility to make sure they contain their dog/s on their property so that they cannot wander at large, lessening the chance of causing an accident & being injured, being attacked, attacking or getting lost

Shire Rangers are within their rights and expected to undertake random inspections to ensure dog owners are meeting necessary requirements!

The Dog Act 1976 requires that dog owners make sure the following laws are followed or penalties may apply:

- A dog owner is legally required to register their dog with the appropriate local government if it is more than three months old. (\$200 Penalty) • A dog is required to wear a collar to which must be attached a valid
- registration tag. (\$200 Penalty)
- All dogs must be micro chipped. (\$200 Penalty)

Common infringements surrounding responsible dog ownership are:

- \$120 Impound Fee if you dog is found wandering
- \$200 Dog in a place without consent of owner/occupier.
- \$400 Dog attack or chase causing physical injury.
- \$200 Dog attack or chase causing NO physical injury.
- \$200 Dog not held by leash in certain public places

The Shire of Toodyay want all of our pets to be happy, healthy and safe. By registering and microchipping your dog it allows us to return your loved one as soon as possi-

President's Pen A quick look back on the past financial year, shows that the Shire finished the year with a small budget surplus, Financial reserves have been maintained slightly above previous levels and the Shire did not borrow any funds

At a special meeting last week, Council agreed to advertise the differential rates proposed for 2017/18.

Several large items of plant and equipment were replaced in line with the long term Plant Replacement Program.

The rate in the dollar has been set to achieve Council's aim of keeping this year's overall rates increase at 2% above last year's level. The proportion of rates collected within each of the rating groups will reflect the 2% increase.

throughout the year. No Shire assets were sold and the scheduled works and services program was completed within Budget.

Unfortunately UV valuations received from the Valuer General's Office indicate substantial differences between individual properties which will lead to a substantial increase for some rural property while others will be receiving a significant decrease in rates for this year. The Shire has no control over these valuations.

Council has based its budget deliberations on the proposed differential rates but will not finalise and adopt the budget until after consideration of public submissions received throughout the 21 day advertising period.

During the same special meeting Council rescinded their July decision to adopt a Health Local law designed to regulate, protect, and manage public health within the Shire. Several amendments to the draft document previously advertised for public comment may be considered to be substantially different to the original. Rather than risk rejection when submitting the Health Law for publishing in the Government Gazette, Council decided to restart the process.

This is a positive opportunity for those who may be concerned by the ever increasing amount of regulation impacting their lives. It's not often residents get a second opportunity to influence the final outcome of such a comprehensive suite of regulations. The draft law will be readvertised giving another six week window for submissions for Council to consider.

A proposal to have a mural painted on the Duke Street ablutions block has attracted quite a bit of social media commentary since the June decision to approve the concept design submitted by the Tidy Towns Committee. TTC has asked for a Shire contribution of \$1500.00 on top of last year's Shire community sponsorship contribution of \$1500.00. The balance of the estimated \$10,000 cost of the Mural and conjunctional local art workshops will be raised by Toodvay Tidy Towns Committee

Council handed TTC the responsibility for organising a concept design in September 2016. Arts Toodyay were invited to submit a design and TTC articles in the Herald highlighted the mural project as well as asking for community input in the September 2016 issue. The approval for the concept drawing to be transferred by a mural artist on to the toilet wall, is subject to a period of public consultation ending 11 August 2017.

This is an opportunity for those who have alternative mural designs and funding source suggestions to have their say prior to a final decision by Council at the finish of the public consultation period.

Following on from a forum presentation by the Electoral Commission, Council has decided to change to full postal voting for the forthcoming Council elections to be held in October 2017. At the last Ordinary Election voter turnout in Toodyay was a low 29.8 % of those eligible to vote. The postal election will be conducted by an independent returning officer appointed by the Electoral Commission. Experience in other locations suggests that a postal election will result in many more people being able to participate in the election.

Please keep in mind that the changed system of voting will be of no benefit unless you are eligible to vote. It is probably a good time to check to see if you are on the electoral role. Registration is not always automatic, particularly if you own property in a different ward than that of your main residence or you reside outside of our Shire.

STORE RIGHT, BURN RIGHT

Do you use a wood heater to keep warm in winter? Smoke from wood heaters is bad for your health and affects winter air quality. There is a lot that you can do to reduce the amount of smoke that your wood heater produces.

Dry seasoned firewood produces more heat and less smoke for your dol-

- · Check firewood is dry before you buy it.
- Pack your wood pile loosely and keep it covered. The wood will dry out faster and stay dry
- Stockpile firewood in summer. You'll have a supply of dry, well-seasoned firewood for the winter.
- Split logs before you store them. Small logs dry faster than big logs.
- Never burn treated or painted firewood.

Did you know it's illegal for firewood retailers in the Perth Metropolitan Region to sell wood with internal moisture content greater than 20 per cent? Ask retailers to show you how dry their wood is using their moisture meter.

If you collect your own wood, make sure you collect dry wood only or plan ahead to allow enough time for it to be dry before you use it. A bright fire gives more heat for the same amount of wood than a dull smoky fire.

A new wood heater that is compliant to Australian and New Zealand standards will produce less smoke than an older model and burn more efficiently.
